

# Gibson Dunn Advising Apollo on Financing of \$2.7 Billion Take-Private of Soho House

(NYSE: SHCO), an international private members' club. Funds managed by affiliates of Apollo have agreed to provide capital in the form of debt and common equity, the proceeds of which will be used to refinance certain of SHCO's existing indebtedness and also fund, in part, the take-private transaction. The take-private transaction has an implied \$2.7 billion enterprise value for SHCP and is being led by MCR Hotels.
