A Gibson Dunn deal has been named [Sustainability-Linked Loan of the Year – Other](#) by *Environmental Finance* at its Sustainable Debt Awards 2025.

The award recognizes a \$50 million sustainability-linked loan facility provided by the International Finance Corporation to support BTG Pactual Timberland Investment Group's Latin American reforestation strategy, particularly in the Cerrado biome in Brazil, one of the most biodiverse, seasonally dry ecosystems in the world.
