Before reentering private practice in 2020, Sarah spent 11 years in the U.S. Attorney's Office for the Southern District of New York (SDNY). She was a trial attorney in the Securities and Commodities Fraud Unit and the Complex Frauds and Cybercrime Unit, Co-Chief of the Money Laundering and Asset Forfeiture Unit, and, finally, Chief of Appeals for the Criminal Division. During her time at SDNY, Sarah conducted some of the Office's most significant investigations of corporate misconduct, tried a number of securities, insurance, and tax fraud cases before federal juries, and argued numerous appeals before the United States Court of Appeals for the Second Circuit.

Sarah is ranked highly in *Chambers and Partners*, with clients calling her "super smart and experienced," "very effective," and "extremely bright and thoughtful." A recent trial win earned her Litigator of the Week, and *Lawdragon* recognizes her as one of the 500 Leading Lawyers in America and 500 Leading Global Litigators.
