From 2019 - 2021, Jimmy served as an Assistant United States Attorney in the United States Attorney's Office for the Southern District of California. During his time at the United States Attorney's Office, he successfully prosecuted a wide range of federal crimes including international money laundering, various frauds and conspiracies, human smuggling, and importation and distribution of controlled substances. Jimmy also successfully briefed cases before the Ninth Circuit and led a successful multi-year investigation involving a complex conspiracy.

Before his tenure at the United States Attorney's Office, he was an associate at Latham & Watkins LLP. During that time, he specialized in white-collar criminal and complex litigation matters, in which he obtained multiple favorable resolutions for his clients.

Jimmy received his law degree from Georgetown University Law Center. While at Georgetown, he was a member of the Georgetown *Journal of Law & Public Policy*.
