Before joining the Justice Department, Prerak served as Chief of Staff to Senator Ted Cruz and as a Chief Counsel on the Senate Judiciary Committee. He ran the Senator's official office, providing strategic counsel on all policy, communications, political, and legal matters. In this role, Prerak also handled numerous high-profile Congressional investigations and hearings, including hearings involving the CEOs of Facebook, Microsoft, T-Mobile, Softbank, Equifax, and dozens more corporate officers and government officials, as well as the confirmation hearings of Justices Neil Gorsuch and Brett Kavanaugh.

Additionally, Prerak personally shepherded the selection, nomination, and confirmation of over 20 federal judges in Texas, developing relationships with judges across the state. Including his time at the Justice Department, he worked on the confirmation of over 150 federal judges across the country. Prerak was also recently appointed by Senators John Cornyn and Ted Cruz to serve on their Federal Judicial Evaluation Committee, which advises the senators on all judicial and US Attorney appointments in Texas.
