- *Starz Entertainment, LLC v. MGM Domestic Television Distribution*: Defended MGM Studios against more than 1,000 copyright claims arising from licensing disputes over MGM's content, resulting in a favorable settlement.
- *Epic Games, Inc. v. Apple Inc.*: Member of the trial team that defeated Epic Games' federal antitrust claims against Apple after a three-week bench trial in a landmark case that Law360 called the "Super Bowl of Antitrust."
- *Linhart v. John Hancock Life Insurance Co.*: Defeated class certification in a putative class action seeking hundreds of millions of dollars in disputed insurance benefits.
