

## Gibson Dunn Names Largest Partner Class In Firm History

*Law360 (December 17, 2025, 3:22 PM EST)* -- Gibson Dunn & Crutcher LLP has promoted its largest partner class in history, promoting 42 attorneys in 17 offices across the globe, effective Jan. 1, the firm announced Wednesday.

Of the newly promoted attorneys, 26% of the class is based in London, which marks the largest partner promotion group ever in that office, according to Gibson Dunn. The firm added that 40% of the promotion class is located in offices outside the United States, significantly exceeding prior years.

"Each member of this incredibly talented group of lawyers does remarkable work on behalf of our clients and makes extraordinary contributions to our firm's community," Barbara Becker, the chair and managing partner of Gibson Dunn, said in Wednesday's announcement. A firm spokesperson did not immediately respond to a request for comment Wednesday.

In 2024, Gibson Dunn elected 35 lawyers from across the firm to its partnership, the same number as in November 2023.

Gibson Dunn had a busy 2025, kicking off the year with the appointment of resolution expert Osma Hudda and real estate finance lawyer Rob Carr as the new partners in charge of the London office.

Later in January, the firm launched a specialized immigration task force aimed at providing clients with up-to-date alerts on the "anticipated complexities and rapid changes in the immigration landscape" under the Trump administration.

In February, the firm welcomed Matthew Axelrod to the white collar defense and investigations practice group and as co-chair of its new sanctions and export enforcement practice group. He most recently served three years as assistant secretary for export enforcement at the U.S. Department of Commerce's Bureau of Industry and Security during the Biden administration.

Gibson Dunn launched a state attorneys general task force made up of subject-matter experts and former government attorneys based in offices across the country in May.

In July, the firm launched a new group focused on aerospace and defense. In the same month, Christopher Harris KC joined the firm as co-chair of its international arbitration and judgment and arbitral award enforcement practice groups.

In November, Gibson Dunn welcomed Duncan K.R. McKay from Fried Frank Harris Shriver & Jacobson LLP to serve as head of fund finance.
